

Consent for Going Offsite, Educational Visits and Sporting Events throughout the Academic Year 2026-2027



Dear Parents/Carers

Your child may have opportunities to participate in different educational visits as well as sporting festivals, fixtures, competitions and integration at other schools and venues within Coventry, Warwickshire, Solihull and Birmingham throughout this academic year (September 2026 - July 2027). Pupils may also be taken offsite, for example to complete local surveys or visit local establishments. These events will take place during the school day and your child will return to school for 3 p.m. The school will send you information about each trip or activity before it takes place. If you wish, you can tell the school that you do not want your child to take part in any particular activity.

This form is valid from 1st September 2026 to 31st August 2027. If you have downloaded the SIMS Parent App, you do not need to return this form; you can review Parental Consents in the App. You will be asked to review and update your consent at the start of the next academic year. You can change consent throughout the year either via the SIMS Parent App or by contacting the school office.

This consent form will cover going offsite, as well as all educational visits and sporting fixtures that take place during the school day this academic year. Details of educational visits and sporting fixtures will still be sent home to help prepare and inform you. Where the visit is more adventurous or goes beyond the school day, further consent will be sought.
